McCrary made a motion to approve the Compliance Plan. Teel seconded. Motion carried 5-0.

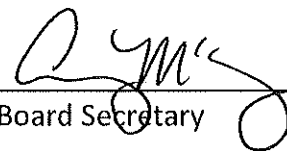
E. CSIP Plan
